3. Report from the Chair

Thanks to Richard for organising the AGM speaker and for his hard work and support.

Hopefully members of the committee will have much to contribute to the committee meeting about the future of our Civic Society. They will be aware that my workload has increased greatly due to a number of factors.

I have had a long telephone conversation with Peter Evans (Ex Chair of Bowdon History Society) who has returned to Altrincham after being in the Lake District for some years. As he is in Altrincham History Society, I will nip upstairs to the first half hour of AHS's meeting on Tuesday to see if he would be interested. I suspect we're not doing too badly with up to date conservation area appraisals and management plans plus the local listing now complete.

4. Planning Update from Paulina

Regarding the LQ New Street situation, we are now waiting for the Planning Application and Consultation.

Lidl have advised that the new Broadheath Store will not be open until after Christmas.

The Latest on Altair is that the site is due to be taken back into Trafford's control by the end of the year. A new developer will be appointed.

The promised Regent Road Memorial Garden has not been created. Talks with the Council and Developer are ongoing.

5. Treasurers Report

Copies of the year end accounts were distributed to the committee. Mr. Stone reported it had been a disappointing year showing a deficit for the year of £339.77. This was due to a fall in membership and increased costs.

The Downs Hotel, Railway Street, Altrincham

Cormac McGowan has confirmed that that the demolished building will be rebuilt to reflect the original building. They are looking to agree a more sympathetic brick finish rather than painted brick. The developer has been salvaging original features for re-use.
